## **ADMISSION INFORMATION**

- Advance admissions to SYJC and T.Y.B.Com., all subjects for VCR and REGULAR Batches for academic year 2018 -19 would commence from TUESDAY, the 11th OCTOBER, 2017.
- 2] Students can secure their Admission by paying ₹.1,000/- on or before 31st March 2018.
- 3] EARLY BIRD DISCOUNT of ₹. 1,000 will be given to those students who secure their admission BEFORE 31<sup>st</sup> December, 2018
- 4] Early Bird Discount will be given at the time of making balance fees payment only. Such payment should be made Before 10<sup>th</sup> March, 2018. Otherwise Early Bird Discount will NOT BE GIVEN.
- 5] Students seeking admission to <u>VCR</u> Batch of S.Y.J.C. / T.Y.B.Com. must pay their balance fees (if any) <u>before the commencement of their batch</u>, failing which they will be barred from attending their lectures followed by cancellation of their admission.
- 6] A Cash Discount of ₹.1,000/- will be given to the student if Full Payment in LUMPSUM for S.Y.J.C and T.Y.B.COM: ACCOUNTS, ECONOMICS MHRM and TAX / COMPUTER is made. Goods and Service Tax [GST] component may be introduced in financial bill. [During Union Budget]. It may result in additional fees of ₹. 200/- To ₹. 450/-.
- 7] Students availing Instalment Facility will be given only 3 instalments (maximum), with Additional Instalment Fees of ₹. 500/-
- 8] If the instalment is not paid on due date, student has to pay late fees of ₹. 200
- 9] Fees must be paid on or before 10th of every month.
- 9] Fees are payable by CASH OR CHEQUE ONLY.

## RULES APPLICABLE FOR REFUND OF FEES

- 1] Students who have taken admission to -
  - VCR BATCHES, ARE NOT ELIGIBLE FOR REFUND.
- 2] FEES ONCE PAID WILL NOT BE REFUNDED OR TRANSFERED TO ANY OTHER SUBJECT OR TO ANY OTHER STUDENT UNDER ANY CIRCUMSTANCES.

- 3] Change of residential address within or outside the city, discontinuation of studies, change of stream, subject disallowed, or any other reason will be no justification for claiming refund.
- 4] STUDENTS HAVING DOUBTS ABOUT THEIR RESULTS OF <u>F.Y.B.COM.</u> / <u>S.Y.B.COM.</u> SHOULD SEEK ADMISSIONS AT THEIR OWN RISK. APPLICATIONS FOR REFUND WILL NOT BE CONSIDERED AT ALL.
- 5] A student who has already secured Admission but whose result is negative [FAILED] is entitled to a Refund after deducting ₹. 2000/- from the fees paid.

  Such refund should be collected on or before 30<sup>th</sup> JUNE, 2018. Any claim after this date will not entertained. Only those students who have paid their fees in FULL are entitled to such Refunds.
- 6] Refund from Advance amount or from part payment is not payable.
- 7] Students and Parents are requested to read rules about refund of fees very carefully before taking admission. Any clarification about this can be obtained from our office. A Zerox copy of the F.Y.B.Com. / S.Y. B. Com. / F.Y.J.C. Mark Sheet indicating negative result, together with the original copy for verification is necessary for claiming refund.
